Minutes of the Meeting

Thursday May 9, 2019

Call to Order: Chairman Ray Langston called the meeting to order at 6:40pm

Pledge of Allegiance: State Senator Don Coram

Welcome Elected Officials, Attendees and Guests: Elected officials in attendance were Sue Hansen, Keith Caddy, Dr. Canfield, Rosemary Murphy, Marc Catlin and Don Coram; Rep Catlin and Senator Coram each gave legislative updates regarding the end of the session.

Chairman's Report:

- The chairman had a conference call with Cory Gardener, Ken Buck and Steve House regarding Democrats and Unaffiliated voters subsequent to the last election cycle; this is seen as an opportunity for Republicans in the next cycle but we have much work to do
- We were given an update on the electoral college petition efforts
